



### 1. Purpose of this Memorandum

This MoU is intended to recognize the general basis for a co-operative and collaborative working relationship between the two parties.

### 2. Nature of this Memorandum

This MOU establishes the basis of cooperation and exchange regarding developing SIGC students' skills in the field of Data Analytics and Data Science. This initiative comes under the CSR initiatives of MathCo and also MathCo's general interest in contributing back to the ecosystem and developing talent for the country.

### 3. Terms of this Memorandum

3.1 MathCo would provide training curriculum and content in Data Science and related topics, for training the students pursuing graduation and post graduation in SIGC

3.2 MathCo would help SIGC find or train the right trainers so that above courses could be offered to students at scale. Based on availability, MathCo would be interested in sending their consultants as guest faculty periodically, to talk about real world examples so that students can get a practical perspective of what they are learning in these courses.

3.3 In the future MathCo would also be interested in providing Certificate / Diploma / PG-Diploma Courses in Data Science and Data Analytics for which the curriculum will be jointly designed by both parties.



3.4 SIGC will involve its faculty and students in the conduct of the training and Certificate / Diploma / PG- Diploma Courses, and the specifics of the training and courses shall be worked out on a case-to-case basis.

3.5 SIGC shall appoint one or more coordinators to manage and handle the events related to the training and / or Certificate / Diploma / PG- Diploma Courses.

3.6 SIGC shall also provide computational laboratory facilities for the conduct of the training and courses.

3.7 The financial aspects of the above shall also be worked out on a case-to-case basis between the two parties.

3.8 MathCo would also appoint one or more contact persons who shall coordinate the training and Certificate / Diploma / PG- Diploma Programs.

3.9 MathCo would be interested in interviewing the students who score well in these courses, by the time of their graduation from SIGC.

#### 4. Status of MoU

SIGC and MathCo recognize that regular and timely communication and consultation are key elements in achieving the purposes of this MoU. The parties will meet once in a month or as required to address issues pertaining to the MoU.

#### 5. Validity of MoU

This MoU will be valid for a period of three years from the date of signing of the MoU. The parties agree to review / renew this MoU three months prior to the termination of the MoU.

#### 6. Termination of MoU

This MoU may be terminated by mutual written consent of the persons occupying the positions of the signatories to this MoU.

## 7. Confidentiality:

- a) The parties each hereby acknowledge and agree that in connection with this Memorandum, they may have access to information that is confidential and/ or commercially valuable to one or more of the other parties ("Confidential Information").

The Parties each hereby acknowledge and agree that they may be both the receiving party in relation to some confidential information ("Receiving Party"), and the disclosing party in relation to some other confidential information (Disclosing Party") and the terms of this Memorandum may apply to a Party as both a Receiving Party and as a Disclosing party, as the context so provided.

- b) To this memorandum, confidential information may include but is not limited to:
- (1) Information of whatever nature relating to the project or to another Party (whether relating to the Project or otherwise);
  - (2) Any information derived from any other information which falls within this definition of confidential information; and
  - (3) Any copy of any confidential information.

But does not include information which:

- (1) Was known or in the possession of the Receiving Party before it was provided to the receiving party by the Disclosing party, provided that it was known or in the possession of the receiving party through legal means and not as a result of any breach of this Memorandum or any other agreement or obligation relating to confidentiality
- (2) Is, or becomes, publicly available, through no fault of the Receiving party.
- (3) Is provided to the Receiving Party without restriction or disclosure by the third party, who did not breach any confidentiality obligations by making such a disclosure;



- (4) Is provided to the Receiving party by the Disclosing party and is marked "non-Confidential"; or
- (5) Is required by law or regulation to be disclosed, but in the event that this exception applies, it applies only to the absolute minimum necessary and provided that the disclosing party is first consulted to establish whether and if so, how far it is possible to prevent or restrict such enforced disclosure.
- c) In relation to any Confidential information:
- (1) The Receiving Party shall keep the Confidential information confidential and secret.
- (2) The receiving party shall only use the confidential information for the purpose of working in good faith on the project in accordance with this Memorandum.
- (3) the Receiving party shall not release the Confidential information to any other party, unless that other party is an advisor who is under a duty of confidentiality.
- d) If there is any doubt as to whether any information constitutes confidential information, the Receiving Party should presume it is confidential information, until the receiving party obtains explicit confirmation from the Disclosing Party that it is not confidential information.
- e) Each Party's respective obligations of confidentiality under this clause will survive the termination or expiration of this Memorandum and will continue for one year after termination.

#### 8. Force Majeure:

A Party shall not be considered to be in default or breach of this Agreement, and shall be excused from performance or liability for damages to any other party, if and to the extent it shall be delayed in or prevented from performing or carrying out any of the provisions of this Agreement, arising out of or from any act, omission, or circumstance by or in consequence of



any act of God, labor disturbance, sabotage, failure of suppliers of materials, act of the public enemy, war, invasion, insurrection, riot, fire, storm, flood, ice, earthquake, explosion, epidemic, breakage or accident to machinery or equipment or any other cause or causes beyond such Party's reasonable control, including any curtailment, order, regulation, or restriction imposed by governmental, military or lawfully established civilian authorities, or by making of repairs necessitated by an emergency circumstance not limited to those listed above upon the property or equipment of the Party or property or equipment of others which is deemed under the Operational Control of the Party.

A Force Majeure event does not include an act of negligence or Intentional Wrongdoing by a Party. Any Party claiming a Force Majeure event shall use reasonable diligence to remove the condition that prevents performance and shall not be entitled to suspend performance of its obligations in any greater scope or for any longer duration than is required by the Force Majeure event. Each Party shall use its best efforts to mitigate the effects of such Force Majeure event, remedy its inability to perform, and resume full performance of its obligations hereunder.

#### **9. Indemnity:**

Each Party to this MOU shall assume the responsibility and liability for the acts and omissions of its own employees, deputies, officers, or agents, in connection with the performance of their official duties under this MOU. For tort liability purposes, no

participating Party shall be considered the agent of the other participating Party. Each Party to this MOU shall be liable (if at all) only for the torts of its own officers, agents, or employees that occur within the scope of their official duties. Under no circumstances shall this MOU be interpreted to create a partnership or agency relationship between the Parties.

#### **10. Severability:**

Any law restraining the validity and enforceability of any provision of this agreement shall not affect the validity or enforceability of the remaining provisions hereof and this agreement shall be deemed as not containing the invalid provisions. The remaining provisions of this agreement shall remain in full force and effect, unless the invalid or unenforceable provision comprises an integral part of or otherwise is inseparable from the remaining agreement.



In such a case, the Parties to this agreement shall attempt to agree on a provision which is valid and enforceable and similar to the original provision.

### 11. Dispute Resolution:

If any dispute or difference of any kind whatsoever may arise between the Parties in connection with or arising out of this agreement or out of the breach, termination or invalidity of the agreement hereof, the Parties shall resolve them by resorting to the following order as mentioned:

(i) The parties shall attempt for a period of 30 days after receipt of notice by the other party of the existence of a dispute to settle such dispute in the first instance by mutual discussions by way of mediation process conducted by accredited mediator between the Parties.

(ii). If the dispute cannot be settled by mutual discussions/ mediation process within 30 days (or any extended period taken for mediation process) as provided herein, the dispute shall be referred to the sole arbitration of any arbitrator appointed mutually. The Party having a grievance shall serve a written notice by registered acknowledgement due post on the other party intimating its intention of invoking the arbitration clause and shall simultaneously serve a notice in the similar mode requesting to appoint an arbitrator.

(iii). The arbitration proceedings shall be held in accordance with the provisions of Arbitration and Conciliation Act, 1996 of India or any statutory modification or re-enactment thereof.

(iv). The arbitration proceedings shall be conducted in the English Language. The venue of arbitration shall be upon mutual consent.

(v). The payment to be made to the arbitrator shall be shared equally between the two Parties. All other expenses incurred by each party relating to the arbitration proceedings shall be borne by the respective Parties.



(vi) Judgement upon any award rendered by the arbitrator may be entered in any Court in India, having competent jurisdiction in relation thereto or the application may be made to such court for a judicial acceptance or recognition of the award and announcements orders enforcement (Including specific performance), as the case may be.


**12. Governing law:**


The MOU shall be governed and interpreted by and construed in accordance with the substantive laws of India. All disputes, differences, claims and demands arising under or pursuant to or touching upon this MOU shall be subject to the jurisdiction of Courts of Tiruchirappalli, TamilNadu.

It has done enormous projects for sustainable development of slums in key areas such as healthcare, education, creation and maintenance of infrastructure and conservation of environment. Human resources are tapped from local communities and government. It has achieved a lot of success through projects related to watershed management, Inclusive education, shelter constructions, children projects, education, self help groups, health and sanitation, promotion of agriculture & protection of cattle, and disaster management.

### 2. About Shrimati Indira Gandhi College

Shrimati Indira Gandhi College is a Self-Financing college affiliated to the Bharathidasan University and accredited by NAAC at 'A' grade during the III cycle in 2015. The college was established in 1984 by the visionary educationalist Vidya Seva Ratnam Shri.K.Santhanam, to provide Higher Education and Economic Independence to girls in particular from rural areas. The college has been making rapid progress in all spheres by the constant support and encouragement by Shri.S.Kunjithapatham, Secretary and Thotta.P.V.Ramanujam, President of the National College Council. Prof. Dr.K. Meena, Former Vice-Chancellor, Bharathidasan University, Trichy has been the backbone of the college and progressively encouraging the staff and students to achieve the Level of Excellence. The college aims to promote the economic independence of women through education.

### 3. Terms of Agreement:

Shrimati Indira Gandhi College and SEVAI together agree to mutually support each other for the conduct of following types of activities.

- i. Integrated village community development.
- ii. Creation of awareness among women, especially illiterate / rural / socially & economically backward women, about
  - Keeping good health
  - Menstrual Hygiene Management
  - Sanitation and environmental preservation
- iii. Creating awareness on rainwater harvesting, use of renewable energy sources, eco-friendly practices and conservation of energy.
- iv. Conduct of short term training programs exclusively for women empowerment.
- v. Inclusive education and care for Differently Endowed children.
- vi. Providing skill based education & training to SHG group clusters and exploiting market potential for SHG products.
- vii. Taking ICT to backward areas, through skills training, awareness programmes and demonstrations. (**IT on wheels**).
- viii. Motivating women and children to study and undergo vocational education to become employable.

Both the organizations have realized their responsibilities towards the progress of the nation and the upliftment of the citizens in general, women and children in particular. Hence they would like to compliment each other for the conduct of the above kind of activities.

### 4. Financial Provisions:

Both organizations would strive to provide all manpower and infrastructure and amenities free of cost for the cause of society. No financial commitments are made. Shrimati Indira Gandhi College would extend the support of its students and faculty members, for the conduct of the Programmes. Instructional material, pamphlets and brochures will also be prepared by them. On the other hand SEVAI would help in reaching the people, the beneficiaries of the operations, provide the venue for the conduct of the activities. The provisions extended by each party will be agreed upon a case by case basis.

## 5. Co-Ordinators:

Shrimati Indira Gandhi College will be represented by a faculty member, who will be nominated as the Co-Ordinator, for the conduct of each programme. SEVAI will be represented by its Director, Shri. K. Govindaraju for co-ordinating the programme.

## 6. Renewal:

The MOU shall be renewed by the authorized representative of both parties, under mutually agreed terms and conditions through renewal applications.

## 7. Amendment:

The MoU may be amended upon the mutual consent of the two parties, as and when required.


## 8. Termination:
